The Minutes of the June 10, 2025, Board Meeting, were, on motion (White/Radtke) made and carried, approved.

Due to the absence of Supervisor Lovato, the planned discussion on funding for the BDP fire truck was tabled until the next meeting.

Reports by elected and appointed officials: Supervisor White reported that 1) 1 Mile Rd. is almost ready for blacktop, which will be done in September; and 2) the deck on the old museum building needs staining to preserve it. Chairman Radtke 1) gave the building permit report; and 2) reported that the annual Children's Fishing Contest was a success and thanked Dianne Adell for her work on the contest.

The Clerk/Treasurer presented the Financial Report and voucher list which were, on motion (Radtke/White) made and carried, approved.

Public Comment: Bill Stankevich reported that 1) the Crivitz to Marinette rail system had been abandoned and will be taken over by the ATV/UTV trail system; 2) the Goodman Field House has been sold to the YMCA for \$1.00. That will save \$35,000 on utilities and will add 1700 square feet for the YMCA to add more services. The pool will continue. The police station may move into the library space on the University of Marinette. In answer to Sue Rohde-Perry's question about work on County O, Mr. Stankevich said the County voted no to borrowing any money for work on County O. Joe Stoll said that the fireworks were good and asked about 2 fire numbers that he thought were on the same property but was advised that those are actually 2 lots requiring 2 separate fire numbers. Jody Anderson reported that one of the pole caps on the Lily Lake pier was missing. Ed Desotell questioned why the fire numbers on 5 properties on Old A didn't appear to be in the right order.

On motion (Radtke/White) the next Town Board Meeting will be scheduled for August 12, 2025, at 6 PM.
