## Dunbar Board Meeting October 14, 2025, at 6:00 PM

## Dunbar Town Hall - Upper Town of Dunbar, County of Marinette, State of Wisconsin

The meeting was called to order by Chairman Bruce Radtke.

The Pledge of Allegiance was recited.

The Agenda, upon motion (White/Lovato) made and carried, was approved.

The Minutes of the September 9, 2025, and October 7, 2025, Board Meetings, were, on motion (White/Lovato) made and carried, approved.

A discussion was held regarding the proposed 2026 BDP Rescue Squad agreement. For 2026, the proposed agreement is for \$31,000.00, which includes \$13,000.00 escrow for equipment and \$18,000.00 for operating expenses. After discussion and on motion (Lovato/White) made and carried, the proposed 2026 BDP Rescue Squad Agreement was approved.

Reports by elected officials: Supervisor White reported that 1) sand and salt supplies are ready for the winter; 2) there is a lot of grading to do; and 3) 1 Mile Rd is complete. Upon his statement that 1 Mile Rd. was complete, resident, Yvonne Tim, complained about the way 1 Mile Rd. was done. She claims it was not pulverized and that there are chunks of pavement in her driveway and yard. Despite the Board's assertion that the road was pulverized, the resident insisted it was not. She brought chunks of pavement with her and threw them on the floor. Supervisor Lovato reported that 1) the Focus On Energy program still has rebates that will expire at the end of the year and also products are available free of charge on their website at focusonenergy.com; and 2) ideas are needed to promote business in town. Chairman Radtke 1) gave the Zoning Administrator report for August; 2) gave the Fire Commission Meeting report; 3) reported that the Municipal Court budget went down per town this year due to Goodman joining the court; and 4) reported that the town had received \$6,700 from FEMA for storm damage from the ice storm.

The Clerk/Treasurer presented the Financial Report and voucher list which were, on motion (Lovato/White) made and carried, approved.

Public Comment: Yvonne Timm would like speed limits posted on 1 Mile Rd. for ATVs. Ed Desotell commented on the fire number discrepancies on several roads.

On motion (Lovato/White) the next Town Board Meeting will be scheduled for November 18, 2025, immediately following the Electors Meeting at 6 PM.
