Dunbar Board Meeting September 9, 2025, at 6:00 PM

Board Members Present: Chairman Bruce Radtke, Supervisor David White, Supervisor David Lovato, Clerk/Treasurer Sue Ann Rohde-Perry, Deputy Clerk/Treasurer Jayne Collins. The minutes were recorded by Deputy Clerk/Treasurer Jayne Collins.

The meeting was called to order at 6:00 PM by Chairman Bruce Radtke.

The Pledge of Allegiance was recited.

The Agenda, upon motion (Lovato/White) made and carried, was approved.

The Minutes of the August 12, 2025, Board Meeting, were, on motion (White/Lovato) made and carried, approved.

A discussion was held regarding the generator used at the gravel pit, which was taken to Ace Hardware for repairs. The town was informed by Ace Hardware employees that the generator cannot be repaired. Ross is checking into a replacement.

A discussion was held regarding the proposed Waste Management Service Agreement which locked in last year's price plus a \$500 bonus. After discussion, and on motion (Lovato/White) made and carried, the Service Agreement was approved.

A discussion was held regarding the need to get bids for crushing 10,000 tons of gravel at the gravel pit. The town used 5,240 tons of crushed gravel last year. On motion (Lovato/White) made and carried, bids will be obtained for the crushing of gravel.

A discussion was held regarding the ARIP Grant Application which needs to be completed. Dunbar was not selected for the grant last year but will reapply this year.

A discussion was held regarding the Fall Budget Workshops which will begin on October 7. The budget must be completed by the third Tuesday in November so that it can be presented to the electors for approval.

Reports by elected officials: Supervisor White reported that 1) final grade work was being done on Barnes Lake Road and Kennedy Drive; 2) some large trees are being removed on Nash St. Supervisor Lovato reported that 1) the Interior Committee would like to do something with the museum building but it might require installing a septic system and water; 2) the ballfield has been sprayed and a cultivator was used on it and it looks good. Chairman Radtke gave the permit report.

Bill Stankevich reported that Marinette County has no money for roads for any towns other than Crivitz and other larger towns. County O is in dire need of work but Marinette County has so far said there isn't any money for it.

The Clerk/Treasurer presented the Financial Report and voucher list which were, on motion (White/Lovato) made and carried, approved.

On motion (White/Lovato) the next Town Board Meeting will be scheduled for October 14, 2025, at 6 PM.
