

**Dunbar Board Meeting**  
**August 12, 2025, at 6:00 PM**  
**Dunbar Town Hall – Upper Town of Dunbar, County of Marinette, State of Wisconsin**

**Board Members Present:** Chairman Bruce Radtke, Supervisor David White, Clerk/Treasurer Sue Ann Rohde-Perry. The minutes were recorded by Clerk/Treasurer Sue Perry. Quorum Present.

The meeting was called to order at 6:00 PM by Chairman Bruce Radtke.

The Pledge of Allegiance was recited.

The Agenda, upon motion (Lovato/White) made and carried, was approved.

The Minutes of the July 8, 2025, Board Meeting, were, on motion (White/Lovato) made and carried, approved.

Discuss/Action: Resolution Authorizing the borrowing of Funds was presented for the purchase of BDP fire truck, to be split by Beecher, Dunbar and Pembine. Discussion whereby the General Obligation Promissory Note would be executed through Incredible Bank for \$158,000.00. Motion (Lovato/White)

Discuss/Action: Brush Grinding bid from TLB Wood Products was discussed. It was determined that there will need to be more discussion and possibly more bids. Motion made to table until further notice Lovato/White)

Reports by elected and appointed officials:

Supervisor White reported that we will be looking to replace culvert on Hwy 8 and White Birch in 2026. One Mile Rd. is almost ready for chip seal, Barnes Lake to blacktop and Kennedy drive ready for culvert and blacktop. CC camp Road needs fill, which is slotted for September. Two Large tree were cut down on Nash Street.

Supervisor Lovato reported that the public works department are doing an awesome job on One Mile Road. Dun Good Riders installed a 25 MPH sign on Old A.

Chairman Radtke Gave the building permit report. If you encounter someone going uncontrollably fast on ATV/UTV vehicles, you should call the Marinette County Dispatch.

The Clerk/Treasurer presented the Financial Report and voucher list which were, on motion Lovato/White) made and carried, approved.

Public Comment: Joe Stoll said that the skunks are back and creating annoyance. Ed Desotell questioned the fire number system. Fire numbers are set by the State using GPS. Ed brought in articles from different towns and counties regarding road improvements and maintenance. He suggested maybe a road referendum could be sought to help improve the roads in Dunbar. Lots of discussion. Trisha Grebin said the school may go after another referendum and thought it would be almost impossible to set another referendum for roads without increasing the levy.

On motion (White/Lovato) the next Town Board Meeting will be scheduled for September 9, 2025, at 6 PM.

On motion (Radtke/White) the meeting was adjourned at 6:40 PM.
